## 1. Forms

This is an application form to apply for both Accreditation as Registered Social Worker-Provisional (RSW-P) and SASW Ordinary Membership. Please note that if you are eligible for accreditation as RSW-P, you will be eligible for SASW Ordinary Membership. The purpose of this form is to facilitate your applications for accreditation and SASW membership so that you need not fill in the same information or provide the same documents twice. Your application for accreditation will be considered by the Social Work Accreditation Board and that for SASW Ordinary Membership by the SASW Executive Committee. Hence, approval of one application does not necessarily entail approval for the other. You will be informed of the outcome of your application for accreditation by the Accreditation Secretariat and for the Ordinary Membership by the Membership Department.

If you are applying for either Accreditation or Membership only, please use the stand-alone Accreditation Application Form and Membership Application Form.

All the forms can be collected from the SASW office during office hours or downloaded from our website at [www.sasw.org.sg](http://www.sasw.org.sg).

## 2. Processing

Please note that the application will only be processed when it is fully completed and all the required documents are attached. Should there be any information or documents missing, the approval process will be delayed. Only original copies of applications will be accepted. You are advised to keep a copy of your application form for your own reference.

## 3. Fees

There is no fee charged for Accreditation.

For SASW Membership, the fee is \$120 for 2 years for Ordinary or Associate Membership and \$10 for 2 years for Student Membership. Each term of membership is 2 years. New applicants will have to pay an entrance fee of \$20. There will be no administration charge for renewal or conversion of membership. However, members whose membership has lapsed for one month or longer will have to pay an administrative charge of \$20. Please check with the Association if unsure of membership status. Kindly enclose payment through a crossed cheque addressed to “**Singapore Association of Social Workers**” with your name, NRIC number and contact number indicated on the reverse side.
